

## **Frequently Asked Questions on BSKY Packages**

### **1. How many packages are there under BSKY.**

At present there are 1589 packages under BSKY. Periodically new packages are added basing on emerging needs.

### **2. Can I get treatment for all the packages in empaneled hospitals?**

Out of 1589 packages, 46 packages are reserved for Government health institutions and another 155 packages can be availed only on referral from a Sub-Divisional Hospital, District Headquarters Hospital or Govt. Medical College Hospital. Rest 1388 packages are open packages. Any beneficiary can directly walk in to any empaneled private hospital and avail the treatment under these 1388 packages, if he is found suitable for that package by the treating Doctor of the empaneled hospital.

### **3. What type of packages are reserved for Government facilities?**

Management of superficial burns, minor injuries, Malaria, Typhoid fever, Gastroenteritis, Diarrhea, Dysentery, Tuberculosis, Urinary Tract Infection, Heat stroke and surgeries for hydrocele, Abscess drainage, Lipoma and cyst excision and procedures like Dilatation and Curettage and Medical Termination of Pregnancy are reserved for Government facilities.

### **4. What do you mean by referral packages?**

Referral from Sub-Divisional Hospital, District Headquarters Hospital or Government Medical College Hospital is required to avail treatment under these packages in empaneled private hospitals. There are 155 packages under this category.

Some examples are – Dengue, Viral Hepatitis, Pneumonia, Arthritis, Recurrent Vomiting with Dehydration, Cataract (Small Incision Cataract Surgery), Glaucoma, Piles, Fissures, Hernia, Hysterectomy etc.

### **5. Under which conditions, a beneficiary can be referred to a BSKY empaneled private hospital for a procedure/package, which is listed under referral category?**

Referral can be done (i) if the particular package/ procedure cannot be provided by a Government facility in the district, (ii) if there is a long waiting time to undertake the procedure at a Government facility in the district, and (iii) where there is an emergency case which requires immediate referral.

**6. Can a beneficiary directly go to an empaneled hospital to get treatment for Road Traffic Accidents, trauma and fracture?**

Yes. In the cases of road traffic accident, trauma or fracture, a beneficiary can directly go to an empaneled hospital for treatment.

**7. If a beneficiary gets a heart attack (Myocardial Infarction), can he directly go to an empaneled hospital without any referral?**

Yes. The beneficiary can directly go to an empaneled private hospital for treatment, where treatment for heart diseases are available.

**8. For Dialysis, is referral required?**

No. For Dialysis referral is not required.

**9. Can a beneficiary go directly to an empaneled hospital for Coronary Artery Bypass Grafting (CABG Heart surgery) procedure?**

Yes. For Heart Surgery (CABG), referral is not required.

**10. Can a beneficiary directly go to an empaneled private hospital for treatment of cancer?**

Yes. Referral is not required for treatment of cancer in empaneled private hospitals.

**11. Is referral required for Chemotherapy and Radiotherapy in treatment of Cancer?**

No. Beneficiaries suffering from Cancer and requiring Chemotherapy and Radiotherapy can directly go to empaneled hospitals for treatment without referral.

**12. Is referral required for appendectomy operation?**

No. For appendectomy referral is not required.

**13. Can beneficiaries directly go to empaneled hospitals for caesarean delivery and treatment of high-risk delivery?**

Yes. Referral is not required for caesarean delivery or treatment of highrisk delivery in empaneled private hospitals.

**14. Are there packages under BSKY for Diagnosis and treatment of Covid 19 in private empaneled hospitals?**

Yes. There are packages under BSKY for RTPCR test, Rapid Antigen test and treatment of COVID-19 in private empaneled hospitals. Beneficiaries can directly go to empaneled private hospitals for investigation and treatment, where these facilities are available.

**15. Is Kidney transplant procedure available under BSKY packages?**

Yes. Kidney transplant procedure is available under BSKY as an open package.

**16. How can I know that which packages are coming under Referral/ Reserved category?**

**17. What types of services are included under packages rate?**

Package rate includes Registration Charge, Bed/ Intensive Care Unit (ICU) charges, Nursing and Boarding charges, Surgeon/ Anesthetist/ Medical Consultants fees, Charges for Anesthesia/ Blood Transfusion/ Oxygen/ Operation Theater charges, Medicines and Drugs costs, diet to patient, Pre (charges for consultation, diagnostic tests & medications) and Post (medicine cost for 5 days on discharge) hospitalization expenses and any other expenses related to the treatment. Apart from the package cost State Govt. also bears the cost of devices/ implants used during hospitalization.

**18. Whether I have to pay any extra amount to empaneled hospital for the complication that may arise during treatment.**

No extra cost is to be paid by the beneficiaries, if any complications arises during treatment. Cost of treatment under BSKY is borne by State Government and there is no out of pocket expenditure, up to the annual assured amount of Rs 5 lakh per beneficiary family (and additional Rs 5 lakh for female members of family)
