Subject: Bhed/Bakri (Sheep/Goat) Palak Utthan Yojana (P-01-10-2403-51-104-86-51-N) for the year 2024-25 (N).

Memo

This scheme is proposed to be implemented in the State for the year 2024-25. The scheme in principle stands approved by the Government in the State Revenue Budget for the year 2024-25 for which an outlay of Rs. 401.00 lakh (Four Crore One Lakh rupees only). This scheme is implemented by Managing Director, HLDB. It is a non-staff scheme and will be implemented with the help of the existing staff.

1. Brief Background

Animal Husbandry is an integral part of agriculture along with a major contributor of Agricultural Gross Domestic Product and endowed with a high potential of self-employment opportunities. In present scenario, when growth rate in crop production is stagnating, it is the animal husbandry sector which holds promise for achieving higher growth rates in State Gross Domestic Product as well as providing employment to the unemployed. There exists a vast potential of self-employment generation in Animal Husbandry and Dairying sector. The establishment of Sheep and Goat units can generate substantial employment (direct or Indirect). There is well-knit infrastructure of veterinary institutions catering to the needs of the livestock owners for providing veterinary and breeding services in the State. Further, self-sufficiency in fodder production, available human resources and vicinity of National Capital Region having ample marketing opportunities makes animal husbandry activities an attractive option for self-employment to the unemployed in the State.

With a primary objective of providing self-employment opportunities, the unemployed persons would be assisted by way of establishing Sheep and Goat units. The pattern of assistance would be in the form of providing 10+1 Sheep/Goat units for SC/BPL/Widow and landless General, BC and Other Category families free of cost. Further assistance would also be provided for insurance of the livestock. In addition to this assistance for purchasing of wool from established unit would be done by the department.

All the animals of established unit will be provided deworming, vaccination and treatment free of cost by concerned Veterinary Institution (Animal Husbandry & Dairying Department).

2. Justification of the scheme:

There are 19.29 lac Cattle and 43.68 Lac Buffalo in the State as per the 2019 Livestock census According to the livestock census 2019, about 16.62 lac families are rearing one or other type of livestock in the state out of which is approximately 20% population of livestock of Schedule caste families which is generally resource poor.

There are 2.89 lakh Sheep, 3.36 lakh goats in the state as per the 2019 livestock census. Out of total Sheep and Goat population 2.0 lac and 2.08 lac respectively is reared by Scheduled Caste families which comprised of 62 to 70% of total Sheep/Goat population. 0.89 lac Sheep and Goat 1.28 lac Goat population is reared by APL and BPL

category in Haryana State. Occupation wise, out of total Schedule Caste families 44% exclusively depends on Animal Husbandry and Agriculture and 56% on other sectors including service sectors. Out of total livestock in the state Scheduled Caste families possess 21% of the livestock. Scheduled Caste families contribute substantively in the Animal Husbandry sector and it is the major occupation these families. BPL, Widow family and landless General, BC and Other Category may also be included under scheme for their upliftment economically.

Therefore, Haryana state has a vast potential of self-employment generation in the animal husbandry sector, the establishment of Sheep and Goat units can generate substantial employment and also increase in livestock products such as milk, meat (Mutton/Chevon), wool etc.

3. Long term objectives of the Scheme:

Long term objectives of this scheme are as follows:

- i. To create self-employment opportunities through Sheep and Goat husbandry activities.
- ii. To upgrade and develop Sheep and Goat breeds/germ plasm available in the State.
- iii. To increase income generation opportunities for economically weaker segment of the society.

4. Strategies:

The beneficiary may get 11 day training for Sheep and Goat Husbandry practices which will be provided by the Department at each Sub Division in the State to the persons desirous for establishing Sheep /Goat units. A total of 572 Sheep and Goat units (286 each) would be established during the year 2024-25 which will boost milk, meat and wool production in the State and also provide gainful self-employment opportunities to 572 beneficiaries in the Animal Husbandry Sector.

5. Implementing agency of the scheme:-

Haryana Livestock Development Board (HLDB), Haryana will be the implementing agencies for this scheme in the state during year 2024-25. the scheme would implement in the entire state and would also be extended for the next year after analyzing outcomes and outputs of the scheme.

6. Roll out plan of the Scheme in terms of Commencement of Activities:-

The Department/Haryana Livestock Development Board (HLDB) would assist the beneficiaries in establishing these Sheep and Goat units in the following ways:-

- i. Imparting 11 days Sheep and Goat husbandry trainings at the concerned Sub Division/ District Level in the State of the desirous persons, if required by applicant.
- ii. Purchase of animals and issuance of Health certificate.
- iii. Providing Veterinary Health and other facilities like free vaccination and management guidance etc.

7. Financial Assistance in form of subsidy for establishment of Sheep/Goat unit under the Scheme:-

- This is a credit linked scheme. Under this scheme back end subsidy would be provided. 100% subsidy for establishment of Sheep and Goat unit of 10 Female and 1 Male would be provided to the SC/BPL/Widow families and landless General, BC and Other Category beneficiaries under scheme. Initially beneficiary has to bear purchase cost of Sheep and Goat unit by there-own for 25% of the unit cost which will be of Rs. 17500/- per unit as margin money (proof for the same should be given by beneficiary), which would be provided to beneficiary account later on as per scheme guidelines. In case of

SC/BPL/Widow category and Landless General, BC and Other Category and rest amount of subsidy i.e. 75% of unit cost would be deposited to the seller account after purchase.

- In case of Scheduled Caste/BPL/widow Category and landless General, BC, Other Category, HLDB/Government will provide financial assistance to the tune of 75 % of the unit cost (Rs. 52500/- per unit) on the establishment of livestock unit after the purchase of livestock to the seller within 15 days positively on submission of all requisite documents.
- The financial assistance of balance 25% of unit cost (Rs. 17500/- per unit) in case of SC/BPL/widow and landless General, BC and Other Category Beneficiaries would be provided by the HLDB/Government in form of subsidy to beneficiary **after two months of establishment of unit subject to verification of unit after purchase of all cases** preferably by Deputy Director concerned himself or its representative not below the rank of Sub Divisional Officer/Semen Bank Officer other than purchase committee.
- Beneficiaries shall have to purchase complete/whole Sheep/Goat unit of 10+1 in one slot and only one beneficiary per household could take the benefit of either Sheep or Goat unit under the scheme.
- The financial assistance would be provided to the account of the seller through Concerned Semen Bank officer by Managing Director, HLDB out of head of overall receipt of Milk Cess funds after verification and recommendation of unit established by Deputy Director concerned or its representative not below the rank of SDO/ SBO. The financial assistance may be delayed due to non-availability of budget or any other unforeseen circumstances.
- The beneficiary would be provided veterinary assistance facilities (Treatment, vaccination and consultancy) by concerned area veterinary institutions free of cost. Assistance for purchasing of wool from established unit would be done by the Department.

8. Financial Assistance for Insurance under the Scheme:-

If any Livestock Insurance Scheme is in operation then the insurance of animals purchased for establishment of Unit is to be covered under that Scheme wherever permissible. If no Livestock insurance Scheme is in operation then the beneficiary would have to arrange for the insurance of the animals on own and the insurance premium shall be paid by the beneficiary.

9. In case of death of Animals / Flock:-

As the whole flock will be insured and the policy holder will be concerned beneficiary. The beneficiary will be the custodians of flock. Whenever such case i.e. death of animal/animals arise, post mortem of the same will be conducted by the concerned Veterinary Surgeon and efforts will be made to settle the claim at the earliest by following the claim settlement procedure as per Insurance Scheme.

10. Eligibility Conditions for an Applicant:

- i. The beneficiary should be of 18 to 55 years of age, a resident of Haryana having Parivar Pehchaan Patra (PPP) and must not be employed even in Private Sector/ Govt. /Semi Govt. Organizations.
- ii. There would be no mandatory educational qualifications or training requirements for availing assistance under the scheme. However, preference will be given to the trained beneficiaries.
- iii. Any group/firm/organization would not be permitted to apply under the Scheme, as the Scheme being an individual beneficiary oriented.

- iv. Any applicant who has earlier availed benefit under any Departmental Scheme for establishment of Goat/Sheep unit would not be eligible for availing benefit under the Scheme.
- v. The applicant would have to upload a self-declaration in the format annexed as **Annexure-I** for being unemployed and for undertaking to abide by other conditions as required under the Scheme in form of affidavit.

Note: - In case an applicant lives at a place other than where the animals are kept or - intended to be kept. Then the jurisdiction area will be the place where animals are kept or intended to be kept (within State of Haryana only).

11. Process of submission of on-line application by the applicant:

Any un-employed person should be of 18 to 55 years of age having Parivar Pehchan Patra (PPP) desirous of establishing Sheep /Goat unit under the scheme would have to apply online on the SARAL Portal: <http://saralharyana.gov.in>. While inviting application online endeavor would be made that applicants from each area of the State can apply for establishment of Sheep /Goat units. The applicants may submit themselves on the portal or through Common Service Centers, Antodaya Kendra, Atal Sewa Kendra, e-Disha Centers or any other such center as provided by the Government from time to time. A unit would be distributed per family per household. The applicants shall also be required to upload scanned copy of following documents during submission of their online applications:-

- i. Bank Pass Book/ Cancelled Bank cheque copy of both seller and purchaser
- ii. PAN Card copy if available
- iii. Schedule caste certificate/ Below Poverty Line/Widow belonging to state (in case of SC/BPL/Widow category)
- iv. Aadhar Card
- v. Self-Declaration Certificate in form of affidavit by applicant
- vi. Training of Sheep/Goat Establishment if any
- vii. Photo of Availability of shed/space for keeping animals
- viii. Proof of landless (Agricultural land) in case of General, BC and Other Category component from concerned Patwari

12. Selection of beneficiaries for establishment of the Sheep /Goat Units:

- Once the applicant has applied online on SARAL portal the application would stand submitted to the Deputy Directors of concerned districts who would thoroughly examine the applications received on portal on **first come first serve basis** and if found not in order the same would be rejected with the comments on portal. However, if application is found in order then accepted and forwarded to the concerned Sub Divisional Officers with in a period of three working days, who will again thoroughly examine and verify with in a period of three working days, if not found in order will be returned to the Deputy Director with comments on portal.
- However, if application found in order then application would be processed for selection of suitable applicant by the following Selection committee.
 - i. Concerned Sub Divisional Officer (AH&D) / Semen Bank officer (Chairman cum Co-Nodal Officer)
 - ii. Concerned Veterinary Surgeon, Govt. Vety. Hospital (Member)
 - iii. Block Level Extension Office, Block (Member)
- The concerned Sub Divisional Officer will intimate the selection committee for meeting with date and venue for selection of applicant in format annexed as **Annexure-II** to the selection committee as well as to the applicant.
- The Quorum of the Committee meeting would be three members including Chairman of the Committee (the presence of officials as mentioned at Sr. No. i. and ii shall be

mandatory). The Committee would select suitable applicants by taking into consideration their entrepreneurship skills, attitude towards Sheep /Goat husbandry and availability of Self-contribution with the applicants. The Committee would generally adopt principle of first come first serve basis, however, if the number of applicants are more, then the Committee shall recommend their applications by prioritizing them on following parameters so that actual resource poor/needy beneficiaries are selected:-

1. Applicant belonging to Below Poverty Line of Scheduled Caste Families & Scheduled Caste Families
2. Applicant belonging to Below Poverty Line Families of other categories
3. Applicant belonging to Widow Families
4. Applicant belonging to landless General, BC and Other Category families
5. Applicant belonging to families having no member in Govt./Semi Govt. Job
6. Families having no livestock but having aptitude and housing facilities to rear Sheep and Goat.
7. Applicant having training in Sheep /Goat rearing, if any.

The proceedings of the Committee meeting would be recorded in writing duly signed by the members present in the meeting. If application of any applicant is rejected the reasons for the same would also be recorded in the proceedings. If application of any applicant found in order then accepted and forwarded to the concerned Semen Bank Officer with recommendation on portal within three working days. The exercise of Selection of beneficiaries and sending to concerned Semen Bank Officer should be completed within seven working days. Concerned Semen Bank Officer thoroughly examined the applications and if found in order transfer back application on portal to concerned Sub Divisional Officer for Purchase of Sheep/Goat Unit through Purchase Committee.

13. Purchase of Sheep/Goat Unit through Purchase Committee: -

- The concerned Sub Divisional Officer will intimate the purchase date and venue for purchase of livestock unit in format annexed as **Annexure-III** to the purchase committee as well as to the applicant.
- Keeping in view for the convenience of the beneficiaries, the venue of purchase of animals would be decided by the concerned Sub Divisional Officers/Semen Bank Officer in consultation with concerned Veterinary Surgeon and it would be either the nearest Government Veterinary Institution or any other nearest Government Institution. The Purchase Committee would have following Members and presence of all members would be mandatory at the time of purchase of Livestock Unit: -

1	Sub Divisional Officer (Animal Husbandry)/ Semen Bank Officer	(Chairman)
2	Veterinary Surgeon, Govt. Vety. Hospital	(Member)
3	Veterinary Livestock Development Assistant	(Member)

- Veterinary surgeon of the area will issue Health Certificate cum purchase receipt, as per the format annexed as **Annexure- IV** in presence of Purchase Committee and duly certified by the purchase committee.
- The approximate cost of animals would be compulsorily recorded in the Health Certificate along with other details. The concerned Veterinary Livestock Development Assistant shall be responsible for Ear-tagging of animals, assisting the beneficiary in arrangement of insurance of animals through insurance company and for maintaining complete records of units established under the scheme.

- The Chairman of the Purchase Committee i.e. concerned Sub Divisional Officer (Animal Husbandry)/Semen Bank Officer would be responsible for insurance of the animals purchased. If any Insurance Company has been empaneled by the Department/ Haryana Livestock Development Board would be done by the same Insurance Company.
- If no Livestock Insurance Scheme is in operation then the beneficiary would have to arrange for the insurance of the animals on its own and the insurance premium shall be paid by the beneficiary.
- The Chairman of Purchase committee will upload a photograph on SARAL Portal duly taken at venue of purchase having Tagged animal, Seller, Buyer and members of committee as per scheme.
- At the time of purchase of animals of Chairman of the Purchase Committee i.e. Sub Divisional officer/Semen Bank Officer would be responsible for collection of all necessary documents viz. Health Certificates cum receipt, Insurance Cover Note/Policy etc. The Sub Divisional Officer will upload all the documents on the SARAL portal after purchase for onward transmission to the concerned Semen Bank officer to initiate the process for release of subsidy as per scheme.
(Note: - No unnecessary documents other than uploaded by applicant on SARAL, Health Certificate, Insurance policy/Cover Note, Interest certificate etc. shall be collected from Beneficiary)
- Concerned Semen Bank officer would release the subsidy as per scheme after checking all the requisite documents thoroughly and send a copy of same to Managing Director, HLDB for information. The Sub Divisional Officer would send a copy of all the documents to Deputy Director for information. Final disbursement of subsidy would be done through concerned Semen Bank officer.

14. Cash Flow Requirement as per Roll out Plan:-

For the establishment of Sheep/Goat unit the Deputy Directors concerned/ or its representative not below the rank of Sub Divisional Officer would sponsor applications through Concerned Sub Divisional Officer after its scrutiny along with recommendation to Haryana Livestock Development Board. Thereafter, financial assistance would be provided by HLDB to the account of the seller/beneficiaries through Concerned Semen Bank officer as per financial assistance of the scheme.

15. Types/Sizes of Sheep /Goat Units to be established under the Scheme:

The details of financial requirement for establishing the units is given as under:-

- i. Only those breeding animals should be purchased which are ready to bred or in prime age of production.
- ii. Sexual maturity age in Female Goat / Sheep is 8-12 months. While in case of Male Goat /Sheep it is 11-12 months. So, female and male Goat and Sheep should be purchased between 12-18 months if age.

16. Description of Sheep /Goat Units for purchasing

1. Only those breeding animals should be purchased which are ready to bred or in prime age of production.
2. Age of puberty in case of female Goat and Sheep is 5-8 months and 7-9 months respectively while in male it is 6-10 months and 8-10 month respectively.
3. Sexual maturity age in case of Female Goat & Sheep is 8-12 months. While in case of Male (Buck and Ram) it is 12-15 months. So, Male and Female can be purchased accordingly.

17. Publicity of the Scheme:

Concerned Deputy Directors, Sub-Divisional Officers and Semen bank officer shall be responsible for wider publicity of the Scheme in concerned District and Sub-Division respectively. Veterinary Surgeons & Block Level Extension Officer (B.L.E.O.) shall be responsible for wider publicity of the Scheme in the concerned block. The Veterinary Surgeon/VLDA and B.L.E.O. shall identify and encourage interested unemployed Scheduled Caste/OBC/BPL/Widow persons for applying under Scheme through SARAL portal and also assisting them in application submission.

Veterinary Surgeon and Veterinary Livestock Development Assistant of the area will also be responsible for publicity of the Scheme in areas under their jurisdiction. The livestock owners would be provided information and encouraged during various Health Care Camps, Kisan Gosthies etc. for self-employment by establishing Sheep /Goat units.

Publicity and Extension Branch at the level of Headquarter shall be responsible for wider publicity and extension of the Scheme in the State through pamphlets, booklets and other extension materials.

18. Verification of Sheep /Goat Units:

The verification of the Sheep /Goat Unit to check physical existence of flock with farmers would be done by a team preferably by team comprising of Deputy Director concerned himself or its representative not below the rank of sub divisional officer/Semen bank officer and Veterinary Surgeon other than purchase committee. Veterinary Surgeon and VLDA of concerned Institution would assist the team. This verification will be done after two months from establishment of the unit for the purpose of disbursement of final financial assistance and further verification will also be done after every six month up-to two years and further reporting to Managing Director, HLDB for final disbursement financial assistance with copy to Director General, Animal Husbandry & Dairying Department Haryana through Deputy Director concerned.

20. Timeline of implementation of program and target date of completion.

This scheme will be implemented during the year 2024-25. The Government is requested that the Administrative-cum-Financial sanction of the Scheme for the year 2024-25 may kindly be accorded for implementation of the scheme under the following budget head:-

Bhed/Bakri (Sheep/Goat) Palak Utthan Yojna (P-01-10-2403-51-104-86-51)- 401.00 lakh.

The Director General, Animal Husbandry and Dairying will be the overall controlling and Drawing & Disbursing officer for the Scheme. Beside this, Semen Bank Officers Hisar, Karnal Bhiwani, Sirsa, Jind, Pehowa, Narnaul, Jagadhri, Gurugram and Rohtak will also be the Drawing & Disbursing Officers of the Scheme.

This scheme is implemented by Managing Director, Haryana Livestock Development Board. For effective and efficient implementation of the scheme if any condition, criteria, parameter of the scheme is needs to be required to amend then Managing Director, Haryana Livestock Development Board, Panchkula would be competent authority for the same.
